## Donation Options

### Available Giving Opportunities

*Please Note: all donor situations vary; please contact your tax advisor for guidance.*

#### Enterprise Zone

Your Director's Circle gift may be eligible for the *El Paso County Enterprise Zone 25% Tax Credit* on your state income taxes, less any non-tax-deductible amount for tangible benefits.

E-Zone payments must be made by check payable to: El Paso County Enterprise Zone with FAC in the memo, along with the last 4 digits of your Social Security #. Please return with this pledge card.

#### Gifts of Stock

If you own shares of stock or mutual funds that have appreciated in value, consider donating these securities to the FAC. These gifts are also eligible for Enterprise Zone tax credit at 12.5%.

#### IRA Charitable Roll-over

The IRA Charitable Rollover provision allows individuals who have reached age 70.5 to donate up to \$100,000 to charitable organizations directly from their Individual Retirement Account (IRA), without treating the distribution as taxable income.

#### Donor-Advised Funds

A donor-advised fund (DAF) is a philanthropic vehicle established at a public charity. It allows you to make a charitable contribution, receive an immediate tax benefit, and recommend that grants from the fund over time be directed to the FAC.

#### Planned Giving

Ensure the FAC's longevity by supplementing future income levels when you name the FAC as a beneficiary in your estate plans.

\* Per IRS regulations, a charitable contribution is a donation of a gift voluntarily made to, or for the use of, a qualified organization. The Colorado Springs Fine Arts Center at Colorado College (Fed. ID No. 84-0402510) is a qualified organization under Section 501 (c)(3) of the Internal Revenue Code. The amount of the charitable deduction is limited to the excess of the amount of the donation over the fair market value of any benefit received.
